Mission Statement:

Spirit Christian Academy is a private, University Model School whose mission is to provide its students with a comprehensive, college preparatory education from a Christian perspective. Spirit Christian Academy exists to provide encouragement to and to help equip parents in the process of educating their children to God's standard of spiritual maturity and academic excellence with the focus on preparing them for a life of service to God and to humanity.

Statement of Faith:

The Bible

We believe that the Bible, which is comprised of all 66 books from Genesis to Revelation, is God's full and complete written revelation to man, given to us by the Holy Spirit. (**John 16:12-15; 1 Cor 2:7-14; 2 Pet 1:20-21**)

We believe that the Bible is inspired in every word, is inerrant, infallible, and is God-breathed. While there may be different applications of any particular passage of scripture, there is only one true interpretation. It is the responsibility of the believer to properly study and apply teachings from scripture under the guidance of the Holy Spirit. (**Mat 5:18; John 7:17; 1 Cor 2:7-15; 1 Thes 2:13; 2 Tim 3:16; 2 Pet 1:20-21; 1 John 2:20**)

God

We believe that there is only one true and living God who is perfect, infinite, all-knowing, and exists in three distinct Persons—Father, Son, and Holy Spirit. (**Deut 6:4; Is 45:5-7; Mat 28:19; John 4:24; 1 Cor 8:4; 2 Cor 13:14**)

God the Father

We believe that God the Father, the first Person of the Trinity, created and orders all things according to His will and purpose for mankind. He is the creator of all things, and is sovereign over His creation. (**Gen 1:1-31; Ps 103:19; Ps 145:8-9; Rom 11:36; 1 Cor 8:6; Eph 3:9**)

God the Son

We believe that Jesus Christ, the second Person of the Trinity, is coequal and coeternal with the Father. He was born of a virgin, was God incarnate, and the purpose of the incarnation was to reveal God, redeem men, and rule over God's kingdom. (**Ps 2:7-9; Is 7:14; Is 9:6; Mic 5:2; Mat 1:23, 25; Luke 1:26-35; John 1:1,14,29; John 5:23; John 14:9-10; Phil 2:9-11; Col 2:9; Heb 7:25-26; 1 Pet 1:18-19**)

We believe that our Lord Jesus Christ accomplished our redemption through the shedding of His blood and sacrificial death on the cross and that His death was voluntary, vicarious, substitutionary, propitiatory, and redemptive (**John 10:15; Rom 3:24-25; 5:8; 1 Pet 2:24**)

We believe that on the basis of the atoning death and physical resurrection of our Lord Jesus Christ, the believing sinner is freed from the punishment, the penalty, the power, and one day the very presence of sin; and that he is declared righteous, given eternal life, and adopted into the family of God (**John 1: 12-13; Rom 3:25; 5:8-9; 2 Cor 5:14-15; 1 Pet 2:24; 3:18**)

We believe that Jesus Christ will return to receive the church, which is His Body, unto Himself at the rapture, and returning with His church in glory, will establish His millennial kingdom on earth. The Lord Jesus Christ is the One through whom God will judge all mankind. (**John 5:22-23; Acts 1:9-11; 1 Thes 4:13-18; Rev 20**)

God the Holy Spirit

We believe that the Holy Spirit is a divine Person, and is coequal with the Father and the Son. It is the work of the Holy Spirit to execute the divine will with relation to all mankind. His divine activity includes convicting the world of sin, of righteousness, and of judgment; glorifying the Lord Jesus Christ and transforming believers into the image of Christ (**Mat 28:19; John 16:7-9; Acts 1:5; 2:4; 5:3-4; 28:25-26; Rom 8:29; 1 Cor 2:10-13; 12:4-6; 2 Cor 3:18; 13:14; Eph 2:22; Heb 10:15-17**)

Mankind

We believe that man was created in the image of God, and that the purpose of man was and is to glorify God, fellowship with God, and seek His will for their lives. (Gen 2:7,15-25; Is 43:7; Col 1:16; James 3:9; Rev 4:11)

We believe that through Adam’s sin of disobedience, man became alienated from God, incurred the penalty of spiritual and physical death, became subject to the wrath of God, and became inherently corrupt and utterly incapable of choosing or doing that which is acceptable to God apart from divine grace. (Gen 2:16-17; 3:1-19; John 3:36; Rom 3:23; 6:23; 1 Cor 2:14; Eph 2:1-3; 1 Tim 2:13-14; 1 John 1:8)

Salvation

We believe that salvation is wholly of God by grace on the basis of the redemption of Jesus Christ, the merit of His shed blood, and not on the basis of human merit or works (John 1:12; Eph 1:7; 2:8-10; 1 Peter 1:18-19)

We believe that all the redeemed, once saved, are kept by God’s power and are thus secure in Christ forever (John 5:24; 6:37-40; 10:27-30; Rom 5:9-10; 8:1, 31-39; 1 Cor 1:4-8; Eph 4:30; Heb 7:25; 13:5; 1 Pet 1:5; Jude 24)

The Christian Life

We believe that, out of deep gratitude for the undeserved grace of God granted to us, and because our glorious God is so worthy of our total consecration, all the saved should live in such a manner as to demonstrate our adoring love to God and so as not to bring reproach upon our Lord and Savior. We also teach that separation from all religious apostasy and worldly and sinful practices is commanded of us by God (Rom 12:1-2, 1 Cor 5:9-13; 2 Cor 6:14-7:1; 1 John 2:15-17; 2 John 9-11)

Release of Liability

As a Christian group, we seek to follow the Biblical mandate that discourages bringing charges against Christian brothers in civil court.

We are a group of Christian families existing as a non-profit organization. Neither our group, nor its leaders, nor its members are liable for any injuries or damages, whether or not connected with Spirit Christian Academy.

It is expected that any member or his child or guest who damages property or who causes injury, either willfully or through neglect, will take personal responsibility for his actions. Any person, whether or not a member, who has such a claim will be directed to discuss the offense individually with the party he believes to be responsible. The outcome of such a problem is out of the realm or control of this group's responsibility. If such disputes cannot be handled by the parties individually, we will expect that they will follow the guidelines of *Matthew 18:15-35* through their own churches and church leadership.

In the remote event of a catastrophe injuring members while at a school event, we require a Medical Release Form for each child to be signed and on file. (One copy with the secretary and one in the field trip packet which we will have on hand at every event.) No child may participate in any activity without such a form being filled out and signed by the child's parent/guardian first.

I have read the above and agree to hold Spirit Christian Academy and its agents' harmless in the event of any damages or injuries to me, to my children, or to my property.

Acknowledgment of Non-Refundable Registration Fee Commitment to Monthly Tuition Payments Fundraising Commitment

I acknowledge that the \$250 per student registration is non-refundable. Registration payment is as follows: \$250 if registering by May 1st. If registering after May 1st, registration amount is \$275. The payment option is as follows: \$100 due upon registering student (by January 31, 2012), balance of \$150 is due May 1, 2012. If registering a student later than May 1, 2012, entire registration is due of \$275. I further acknowledge that my child(ren) will not be **fully enrolled** in Spirit Christian Academy until such time as my complete registration and enrollment package is received and completed in its entirety, including full payment of registration. Failure to complete the forms as required or any missing documentation will result in unnecessary delays in processing, including student class enrollment.

It is further acknowledged and understood that if my student is a returning student, they will be given priority for registration. Siblings who have not previously attended Spirit Christian Academy, but who are registering for the first time for the 2012-2013 school year, will be given priority over the students currently on the waiting list based on space availability. I also acknowledge that if I do not have my complete registration/enrollment package returned to Spirit Christian Academy by the end of the priority registration period (**January 31, 2012**) that I give up my priority status to those on the waiting list.

I also acknowledge that tuition payments are due the 1st of each month beginning with August 1, 2012 and ending May 1, 2013 and that a late fee of \$25 will be assessed after the 5th of each month if tuition has not been paid. If full tuition has not been paid by the last day of the month our students will not be able to return to classes the following month, which may result in the loss of our child's enrollment. If a secondary student withdraws after the designated add/drop date tuition needs to be paid for class(es) for the remainder of the semester. If an elementary student withdraws, a 30 days notice/payment must be given. If check is returned by the bank a fee of \$25 is charged to account. In any given year, if three checks are returned by the bank all future payments must be made in guaranteed funds.

Lastly, I acknowledge that our family will participate in fundraising totaling \$350 *in profits* for the school year. If I do not reach the goal of \$175 per semester I will be billed in January for the balance owed for the first modified semester and then again in May for the balance owed for the second modified semester. If a family withdraws from Spirit Christian Academy during first semester, first semester fundraising balance is due (\$175). If a family withdraws any time after first semester, the entire amount is due (\$350).

STUDENT CODE OF CONDUCT

The purpose of Spirit Christian Academy's (SCA) Code of Conduct is to promote a Christ-like attitude in its learning environment and to encourage the development of positive Christian relationships among its students. While on-campus concerns are primary, SCA reserves the right to address any off campus conduct deemed to be significantly affecting on-campus relationships and/or learning environment.

- Love, honor, and obey the Lord Jesus Christ.
- Treat each other with respect, kindness, purity and compassion just as God commands us in Matthew 7:12, *"So in everything do to others what you would have them do to you,"* and in 2 Timothy 2:22, ***"Flee the evil desires of youth, and pursue righteousness, faith, love, and peace, along with those who call on the Lord out of a pure heart."***
- Show respect to adults at all times. A title (Mr., Mrs., Coach, etc.) should, therefore, be used when addressing an adult. In addition, a godly attitude towards fellow students, parents and Spirit staff is required at all times.
- SCA operates on an honor system with its students. Each student is responsible for their own submitted work. Any unauthorized copying of other students' work, engagement of plagiarism or cheating of any kind will not be tolerated.
- Students are expected to be truthful, honest, and upright in their words and actions as a matter of personal conscience and beliefs. Lying, dishonesty, impure speech, gossip, profanity, or behavior in matters pertaining to any facet of school life – academics, activities, and personal relationships – can result in consequences that lead toward expulsion.
- Public displays of affection between sexes such as handholding, kissing, hugging, etc are not permitted.
- SCA expects its students to practice sexual integrity and sexual purity by abstaining from any sexual acts outside of marriage as directed by the Word of God. Students engaged in immoral activity while attending SCA may result in expulsion.
- Harassment of another student, or employee of SCA, whether it be verbal, sexual or physical, may result in expulsion. **This includes postings and comments made on the internet (e.g. MySpace, Facebook, etc.).**
- Gossip and bullying will NOT be tolerated at SCA. Spirit Christian Academy is a Christian school where students are expected to obey the commandment from Jesus in **John 13:34**, where Jesus commanded that we ***"...love one another."*** Students engaged in gossiping and/or bullying other students may result in immediate expulsion.
- Maintain appropriate grooming and clothing standards according to the Spirit Dress Code.
- The school facility and grounds should be kept clean, orderly, and in a manner that shows an attitude of gratefulness.
- Complete all assigned course work at home and *return it on time*, as requested by teacher.
- Arrive *promptly*, with a good attitude and be ready to fully participate in Spirit classes.
- Unless authorized by the Spirit administration, electronic equipment may not be brought to school; including, but not limited to, audio devices such as CD players, iPods, or video games. Cell phones are permitted, however they **must be turned off during class**.
- Seniors who have written permission on file from their parents may leave campus for lunch on Tuesdays and non-chapel Fridays once they have checked out in the office. Students may only drive themselves. All other students must stay on campus during lunch. Students will not be allowed to sit in their cars during a free period for safety purposes.

**MANDATORY DRESS WHILE ON CAMPUS DURING SCHOOL HOURS AND AT SCHOOL
FUNCTIONS***

(*Exceptions MAY be made for field trips, service projects, and special events by Administration approval only.)

TOPS:

- Spirit approved SCA logo t-shirts
- Spirit approved SCA logo sweatshirts with a collared shirt or SCA logo t-shirt underneath
- Collared shirts (polo, standard, or turtle-neck style only, no mandarin collars), short or long sleeved, buttoned up to just below the collar bone for boys and girls
- Spirit distributed jerseys are allowed to be worn on game days.
- *No sweaters are allowed to be worn without a collared shirt or Spirit- t shirt underneath*

BOTTOMS:

- Pants, jeans, knee-length shorts and knee-length skirts
- Shorts, skirts and dresses must be the appropriate length, measuring one inch above the knee or longer.
- Leggings or tights can be worn ONLY under knee length skirts or dresses
- Girls may wear dresses as long as they meet the requirements for both tops and bottoms.
- Pants must be worn correctly (NO sagging)
- Leggings and “Jeggings” are NOT pants. ☺

SHOES:

PARENT RESPONSIBILITIES

1. As parents, you are the primary source of learning for the student, teaming with Spirit teachers.
2. Parents are responsible for enforcing the Student Code of Conduct.
3. Parents are responsible for purchasing curriculum and supplies as outlined in the curriculum guides for each grade level. All curriculum **must** be purchased and received before September 1st, 2012.
4. Parents will be requested from time to time to help out with transportation for field trips, act as chaperones or assist with special events.
5.
 - a. Secondary Parents, with no enrolled Elementary children, are required to serve approximately 10 times each school year to help clean the upstairs, downstairs and outside of the educational wing. We encourage families to help with the cleaning. This requirement is broken down by semester of a mandatory 5 cleanings per semester. You may elect to pay \$20.00 for each required duty ($20 \times 10 = \$200$) instead of serving so that we may “hire” someone to fulfill your responsibility.
 - b. Elementary Parents, with or without enrolled Secondary children, are required to serve approximately 10 times each school year helping to watch the gate leading to the parking lot before and after school; and help to clean the upstairs, downstairs and outside of the educational wing. We encourage families to help with the cleaning. This requirement is broken down by semester of a mandatory 5 cleanings per semester. You may elect to pay \$20.00 for each required duty ($20 \times 10 = \$200$) instead of serving so that we may “hire” someone to fulfill your responsibility.
*Maximum of two gate duties per semester, maximum of one elementary lunch duty per semester.
6. Parents are requested to advise core teacher(s) of any change in the home or student's environment that would affect the student's academic performance (i.e. vacation, prolonged illness, etc.)
7. Parent questions or concerns regarding student performance or work should first be directed to the core teacher. If the parent is not satisfied with the outcome, they may request a meeting with the School Administrator. If satisfaction is still not obtained, the parent may request a special meeting with the School Board. Any decision of the School Board will be final.
8. At least one parent must attend the *mandatory* Parent Meetings held in September, January and May. There will be a \$25.00 fine for “no shows”.
9. Tuition must be paid on time, which is by the 1st of each month. A late fee of \$25 will be assessed if tuition is received after the 5th of the month. If tuition falls behind more than one month, your students will not be able to attend classes until tuition is brought up-to-date. For example, September's tuition is due September 1st. If by October 1st, September's tuition has yet to be paid then your student(s) will not be able to attend classes in October. If you are having financial difficulty, please contact the Administrator or a board member.
10. Attendance forms are due the 1st of each month. A \$25 late fee per family will be assessed if they are received after the 5th of each month. Please place your attendance sheets in the attendance file.
11. Students must arrive on time for class. It is the parent's responsibility to properly notify appropriate Spirit staff if the student will be late for class. If your student has your permission to be dismissed early from class(es) on a Spirit school day, properly notify Spirit staff and sign your student out in the office prior to leaving campus. 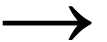
